The Instructional Affairs Committee meeting was called to order by Trustee Yeary at 3:07 p.m. at the Business and Continuing Education Division Corporate Training Room.

I. <u>BOARD ACTIONS/CONSENT AGENDA</u> (All Actions requiring a vote.) A quorum being present, the February 23, 2016 agenda was approved. The October 27, 2015 minutes were postponed until the next Instructional Affairs Committee Meeting for which a date has not yet been determined.

## II. DIVISION REPORTS

#### A. Academic Affairs Division – Dr. Tonja L. Ringgold, Vice President

Dr. Ringgold reported that during the December 2015 Middle States Conference, the overwhelming topic in plenary sessions and the Presidents, Provost, and ALO breakfasts' was the institutional vote which occurred on January 15, 2016 on the MSCHE framework of proposed changes to accreditation on processes and cycle. Dr. May, along with many other Presidents have voted to support these changes.

The key components of the proposed processes include the following:

- A Self-Study and Evaluation Team Visit that will include a separate document review to confirm that the institution meets the Standards, freeing the Self-Study Report to focus more directly on institutional initiatives and improvements.
- An Annual Institutional Update submitted electronically by the institution, about which the institution will receive useful feedback.
- An offsite Mid-Point Peer Review of the accumulated information from the Annual Institutional Update between Self-Studies. The institution would not be required to produce a separate report for this review, eliminating the Periodic Review Report.
- An eight-year cycle for Self-Study evaluations.

Dr. Ringgold reported that The Music program presented "Holiday and the Arts" on December 17, 2015. This was a concert by the BCCC choir made up of students and community members. The choir will be performing a Spring Concert in May and will also sing at this year's commencement ceremony on June 4, 2016.

Trustees Gillett-Karam and Owens Southall inquired if it would be the same self-study team for the 8 year cycle. Dr. Ringgold responded that the annual updates would be reviewed by the Commissioners along with the Vice Presidents of the Commission.

## B. Business and Continuing Education Division (BCED) – Mr. Gregory Mason, Vice President

Vice President Mason reported that the division is in discussion with the BWI Business Partnership on expanding the college's presence in the Cherry Hill community. The college has been partnering with the New Era Academy to elevate the priority of workforce development in the Cherry Hill community by providing ABE, ESL and Career & Technical Education programs. This partnership has expanded to include The Maritime Academy, and Under Armor. The ABE/GED are expanding sites and have request for more but are being met with budget constraint, which is a factor when responding to more requests.

BCED in partnership with the American Society of Home Inspectors will begin offering Home Inspection training at the Preston Street training center beginning in March. BCCC will be partnering with The Department of Energy to host an open house next month at the Preston Street Training Site, in which the Secretary for the Department of Energy will be in attendance. Specifically to highlight the College's training program in energy conservation.

Trustee Owens Southall asked what will be the revenue impact of these new partnerships. VP Mason responded for the Supply Chain Management there will be 100 students, which will be grant funded initially. The goal is that Johns Hopkins will pay for the incumbent worker training. VP Mason anticipates about 300 additional students.

Trustee Owens Southall requested a revenue breakdown of the aforementioned projects. VP Mason will submit the breakdown requested.

Trustee Gillett-Karam has requested in addition to the revenue impact, and enrollment projection, that it should include how many of these programs have been certified. This information should be included for any new program. Trustee Owens Southall inquired if there is a formal policy or procedure to ensure that the noncredit program has been approved.

Trustee Gabriel suggested that Entrepreneurship be added to new programs. VP Mason responded that BCCC has been meeting with the Small Business Administration and the budgetary constraint has been the issue. A need has to be identified for this program before BCCC can commit resources to ensure there is a return on the investment.

Trustee Gillett-Karam requests that enrollment numbers are made clear in reports.

## C. Institutional Advancement, Marketing, and Research Division – Ms. Maureen K. Corneal, Vice President

Vice President Corneal reported that the JCR study proposal and agreement has been finalized and is due May 1, 2016. On Nov. 3, the Vice President of IAMR joined Dr. May and attended a special meeting of Baltimore anchor CEOs to share information, unify conversations and develop a shared leadership agenda to promote and support Baltimore in moving forward in the aftermath of Freddie Gray's death and subsequent unrest.

VP Corneal also reported that Academic Works, new scholarship management systems for the Foundation, successfully launched. More than 137 scholarship applications were entered into the system for the spring. The Foundation Scholarship Committee awarded 32 scholarships which totaled \$13,245. The Foundation launched a crowd funded campaign which brought in \$3,425.

The Grants Development department Year-to-date performance for grants development is \$7,510,000 (77% to goal); of that, \$1,099,700 is New Grants (48% to goal) and \$5,900,810 in Continuation/Renewal funding (87% to goal).

Trustee Gabriel asked if there has been an update to the BCCC Alumni Association and VP Corneal reported that not much progress has been made due to a struggling database. A strategy that will be utilized is to post a LinkedIn page to invite Alumni to get updated information for the database. There are currently no scheduled Alumni Activities/Events.

Trustee Wamalwa suggested that there be one social media site to connect to the various clubs at BCCC. Trustee Wamalwa also suggested engaging students in the process and perhaps having a blog post by students detailing their experience at the College. VP Corneal would like to review and revise the social media policy. Trustee Harris Tildon asked if there was a comprehensive list of alumni who is contacted quarterly. VP Corneal stated there was a list that was cleaned in 2013 but is looking to clean the list again.

Trustee Owens Southall suggested that BCCC engage with recent graduates. Trustee Owens Southall also suggests running a query with surrounding 4 year institutions and perhaps hosting a reception at the institution, in addition to many of the nearby hospitals, locations where BCCC students work.

D. Student Affairs Division – Dr. Tonja L. Ringgold, Interim Vice President Dr. Ringgold introduced the new Interim Director of Student Life, Mr. Jeff White. The BCCC/American Red Cross Faculty, Staff and Community Holiday Blood Drive was held on December 15th. The theme of the blood drive was "Give Something that Means Something." The College's goal was to collect at least 30 pints of blood. One donation could save the lives of as many as three people! Staff at BCCC recruited potential blood donors.

Dr. Ringgold reported that under Enrollment Management there is a calling campaign for the testing center in addition to the robo calls to get students to register.

For the second consecutive season, Tara Owens, Head Coach of the BCCC women's basketball team, was named 2016 Maryland Junior College Athletic Conference (MD JUCO) Coach of the Year. Student, She'cquan Bailey was named 2016 MD JUCO Player of the Year. Coach Owens invited everyone to attend the upcoming Championship game against Harford Community College.

## III. <u>NEW BUSINESS</u>

## A. New Academic Programs

Dr. Ringgold reported BCCC will be forwarding new program proposals to the Maryland Higher Education Commission for approval. The programs include Actuary Science, Pure and Applied Mathematics, Science Transfer and Fashion Design: Retailing. The goal is to not only make sure BCCC aligns with MHEC has but to also meet the industry standard. 21 out of 29 of our programs are AAS programs. Dr. Ringgold showed the alignment between our programs and the BWIB projected occupational openings.

# B. Relationship Between Academic Programs and Continuing Education Programs

Dr. Ringgold and VP Mason are formalizing the transition from non-credit to credit. While creating this partnership we will provide greater connections to credit education to facilitate non-credit students' access to credit degree programs, generate meaningful outcomes that can aid in strategic planning for alignment of non-credit to credit programs, and direct resource-allocations and facilitate the long-term pursuit of degrees. Greater coordination will allow BCCC to connect its non-credit and credit programs in innovative and meaningful ways to benefit students and employers. Students in the BCED Cyber Academy (Cyber Pathways Across Maryland initiative- A+/Net+, Cisco, Pre-Cyber Security) will have the opportunity to matriculate into Computer Information Systems, Computer Aided Design and Cyber Security.

Trustee Wamalwa asked what structures are in place to ensure student success? Dr. Ringgold mentioned that there are dedicated Pathways advisors in addition to faculty advisors.

Trustee Paulk inquired does this partnership allow students to get over hurdles. For example, would students have to take the Accuplacer? VP Mason responded Yes students would still have to take the Accuplacer. For prior learning assessment students could produce a portfolio.

Trustee Gillette-Karam asked if there was a timeline for this partnership. VP Mason stated that the goal for GED students is a 10% increase. Dr. Ringgold stated formulation of the MOU will be completed this spring and will roll out in this fall.

## VICE PRESIDENT'S REPORT

Tonja L. Ringgold Ed.D. Academic Affairs Division (AA)

The Division of Academic Affairs has been very busy this past fall semester developing programs and updating college syllabi for every course in BCCC's inventory. New partnerships were forged as well as the significant launch of P-TECH high schools at Dunbar and Carver. Listed below are highlights of Academic Affairs activities for fall 2016 and a schedule of upcoming events and projects.

#### New Program Development

- The department of Education, Social and Behavioral Sciences will be presenting two new certificates to the Curriculum and Instruction Committee (CIC); Religious Studies Certificate and Religious Studies/Philosophy Certificate. Also, presented two new programs AAS Degree in Religious Studies and AA degree in Religious/Philosophical Studies.
- A MOU between the Clarence Blount Center and Family and Children Services of Baltimore has been completed and is signed. It provides for seniors who serve as foster grandparents at the Center. The Foster Grandparent program has been long established across the country and is an important connection between the College and community. The initial cohort of students will start on January 29, 2017

#### Partnerships with Senior Institutions

- Coppin ADN to BSN Early Dual Enrollment Nursing students complete BSN courses at a four year institution while enrolled in ADNs program at BCCC Three to five students enrolled annually.
- University of Phoenix Articulation and Early Dual Enrollment Nursing students complete BSN courses at a four year institution while enrolled in ADNs program at BCCC Five to ten students enrolled annually.
- Bellvue University BCCC has established a partnership with Nebraska-based Bellevue University in order to provide BCCC graduates an opportunity to transfer all of their BCCC college credits and apply them toward an online bachelor's degree at Bellevue, in a career field of their choosing.

• University of Baltimore "Bee Line"- The new partnership and articulation agreement between BCCC and the University of Baltimore (UB) ensures BCCC students will be able to transfer seamlessly to UB. As students complete their studies at BCCC, UB's Bee Line transfer program will assist and provide benefits to those who wish to transfer to UB. The program will allow students to transfer as many as 63 credits, receive transfer scholarships if eligible, and become involved in UB's Helen P. Denit Honors Program. The program also



guarantees admission and waives the UB application fee.

#### Scholarships/Grants

- Kaiser Health Professions Scholarships funds provide tuition support and books to support student retention, persistence and completion. 10-15 eligible students in SNHP programs will receive financial support during the 2015-2016 AY.
  - \$50,000 End date June 2017 (end date extended)
- Kaiser "Men in Scrubs Project" Grant (MISP) Men pursuing a career in healthcare will receive exposure and mentoring on unique aspects of the field as a man. 30 men interested in healthcare or currently enrolled in a SNHP program currently participate in MISP.
  - \$27,000 End date June 2017
- Kaiser Equipment Grant funds support the purchase of clinical and simulation equipment to enhance and expand teaching and student success in SNHP programs. Surg. Tech, PTA, RC, and HIT programs will purchase new equipment.
  - \$85,000 End date July 2017
- **CareFirst Equipment Grant** funds support the purchase clinical and simulation equipment to enhance and expand teaching and student success in SNHP programs. Surg. Tech, PTA, RC, and HIT programs will purchase new equipment.
  - \$157,361 End date July 2017
- **Perkins Equipment Grant** funds support the **p**urchase clinical and simulation equipment to enhance and expand teaching and student success in SNHP programs. All SNHP program will purchase new equipment.
  - \$31,800 End date July 2017

# VICE PRESIDENT'S REPORT

Gregory Mason, Vice President Business and Continuing Education Division (BCED)

The Business and Continuing Education Division continues to focus on expanding its workforce development programs, integrating ABE/ESL programs with Workforce training initiatives and maintaining good fiscal stewardship of its resources.

## Projects & Growth Opportunities

## ESL and Basic Skills

- The Citizenship Preparation Program was awarded a grant from the Maryland Office for Refugees and Asylees (MORA) to provide naturalization services to elderly refugees in the Baltimore area. The grant, totaling \$86,493.78 for two years targets those refugees that still have not received US Citizenship, as well as connects them with public assistance programs to meet their needs.
- The English Language Services & Basic Skills Department hosted a very well attended Partners Meeting.
- Meeting on October 27<sup>th</sup> at the Harbor Campus. Representation from over 30 partner organizations attended to learn more about the offerings of BCCC's ELS programs as well as discuss ways in which they can seek additional partnerships with BCCC.
- BCCC's Refugee Youth Project was featured on WMAR ABC 2's teen news segment, highlighting the ArtWorks program. ArtWorks is a program that allows RYP students to express themselves and their culture through creativity and creation.
- In partnership with National Geographic, BCCC's Refugee Youth Project took 18 youth on a four-day hike through the Appalachian Trail in October. The purpose of the camp was to introduce participants to the power of photography through visual storytelling, encouraging them to share their own journeys as refugees.
- In preparation for the full implementation of the Workforce Innovation and Opportunity Act (WIOA), representatives from both the English Language Services and Adult Basic Education departments have participated in a series of workshops and retreats at both the state and local levels to ensure that adult education programs at BCCC are both in line with the new regulation, as well as leading the way for the city of Baltimore.

# Adult Basic Education

- To meet the specific needs of our students the following classes were added:
  - Accelerated Math
  - Accelerated RLA
  - Accelerated Social Studies/Science
  - Math Clinic
  - RLA Prep
  - RLA Clinic
  - Nine new Math Prep classes
  - Computer Literacy in the context of the GED
- In collaboration with the Center for Urban Families and the Department of Health and Human Services, BCCC is supporting the Baltimore Responsible Fatherhood Project by providing basic skills (Pre GED) and computer literacy courses.
- One Baltimore for Jobs (1B4J) BCED received a contract from America Works through the Mayor's Office of Employment Development to provide basic skills (Pre GED) and computer literacy courses.
- Jobs-Plus Initiative Program BCCC is serving Baltimore City Gilmor Homes residents who lack basic academic and computer literacy skills under a \$2.4 million grant made to the Housing Authority of Baltimore City (HABC) by the Department of Housing and Urban Development (HUD).
- Initiated 7 new community partnerships
- Launched bridge classes in health care and warehouse logistics to integrate ABE with workforce skills training.

## Workforce Development

The BCED Pre-Cyber Security Program has launched 2 additional A+ certification cohorts with an enrollment of 20 students and 1 Network+ certification with an enrollment of 12 students. BCCC has partnered with Minotech Solutions to generate job experience and job retention. A student who was diagnosed with autism at the age of 4 has successfully completed A+ certification program with a GPA of 98%. He is now practicing for his A+ certification exam and has been hired by our partner company Minotech. This student has also volunteered 8 hours a week to assist students with preparing for their certification exam. He will be enrolling in the Network+ program that begins in February 2017.

The program has targeted veterans, women and high school graduates for this program to generate a more diverse population for this industry. Our focus is still 50% men and 50% women for program completion and to date we are at a 63% men and 37% women program completion.



# VICE PRESIDENT'S REPORT

Dr. Nassim Ebrahimi

Interim Vice President for Institutional Advancement, Marketing, and Research (IAMR)

IAMR respectfully submits the following divisional updates (September 2016 – December 2016):

#### Office of the Interim Vice President:

The Interim Vice President for IAMR transitioned to interim role by meeting with all direct reports and reviewing all vacant positions and positions descriptions. She continues to support divisional and college-wide efforts, including but not limited to BCCC's response to the JCR study, Monitoring Report and follow-up initiatives, press releases, media advisories, Community Forum, Convocation, mission and vision review, Achieving the Dream application, BCCC Foundation, and various search processes.

#### **Grants Development:**

The year-to-date performance (July 1, 2016 – December 16, 2016) for grants development is \$5,201,349 (64% to FY2017 goal of \$8,177,087); of that, \$594,159 are New Awards and \$4,607,190 in Continuation/Renewal funding. Dr. Towson has also provided oversight to the Institutional Review Board (IRB) and has reviewed administrative IRB protocols that do not require full IRB review/approval. Currently, Dr. Towson is recruiting new IRB members from faculty and staff.

#### Office of Institutional Research:

- The Office of Institutional Research, in collaboration with departments across the College as needed, successfully completed and submitted:
  - all State and Federal reporting requirements, including but not limited to reports to the Maryland Higher Education Commission (MHEC), Maryland State Department of Education (MSDE), Integrated Postsecondary Education Data System (IPEDS), Maryland Association of Community Colleges (MACC), Department of Budget Management (DBM), and Department of Legislative Services (DLS);
  - provided data necessary to complete the FTE component of the College's external financial audit coordinated by the Business and Finance Division;

- the Monitoring Report for Middle States Commission on Higher Education (MSCHE), including a successful site visit and preparation of the institutional response;
- the application for Achieving the Dream;

# VICE PRESIDENT'S REPORT

The Vice President for Student Affairs is pleased to share the following updates in the Student Affairs Division:

#### Office of the Vice President of Student Affairs

Focus since November 2016 has been on organizational culture and making connections to Baltimore-area organizations.

- Student Affairs Division Forum to launch efforts to evaluate and refine the connection between our activities and a student experience that promotes higher levels of retention and graduation.
- Student Affairs Leadership Team (SALT) restructured to develop assessment measures and to improve collaborations
- Baltimore College and Career Readiness Network: Participated in launch meeting to coordinate early college and dual enrollment efforts.
- College Bound: Hosting the spring counselors' professional development meeting.
- Central Scholarship: Discussions to connect BCCC career development students with funding opportunities.

Participated in state-wide and national activities

- The Washington Center: Participated in meeting to expand opportunities for BCCC's Granville T. Woods scholars and to apply what works in those scholars' success to the overall BCCC student experience.
- Selected to be the higher education representative on the Educational Coordinating Council of the Juvenile Services Education System (ECC JSES).
- Attended the Maryland Association of Community Colleges (MACC) summit on college completion
- Attended the annual Middle States Commission on Higher Education (MSCHE) conference
- Invited participant at the My Brother's Keeper (MBK) Milestone Discussion and *All the Difference* Screening at the White House.
- Attended the DC-Maryland Campus Compact annual President's Institute and moderated a session on institutional research for student service learning outcomes

## Enrollment Management

- Mayor Catherine E. Pugh has been confirmed at the keynote speaker for Commencement
- We launched Accuplacer testing on-site at 10 Baltimore City Public High Schools
- Hobson's, a computer-supported system to enhance recruiting activities, went live on Dec. 12th
- On December 13th, BCCC's Office of Admissions hosted an Informational Session for the Dual Enrollment Program. There were 26 students and 3 parents in attendance from 13 City Schools to either learn more about the program or register for Spring 2017 courses.
- In response to a request from City Schools, we developed a "Program Cost Comparison between BCCC and For-Profit Institutions" to provide students with information concerning affordability of work-ready certificate programs

#### The Office of Judicial Affairs and Title IX

- The campaign called "Title IX...One student at a time" began the Fall 2016 semester with a focus on Preparation for Academic Achievement (Pre-100) classes and a goal of presenting to at least 500 students per semester. The goal was achieved with a total of 504 students reached.
- We have been reforming our support for students who commit minor infractions of the BCCC Student Code of Conduct with an eye on ensuring that the students get what they need to make academic progress. Beginning this spring, students can engage in a Restorative Justice process that emphasizes repairing the harm caused or revealed by violations.

#### Student Development

## Disability Support Service Center

- Established Title-IX website on the BCCC website details the reporting process, lists committee members, and consent issues.
- Interim Director Spencer-Allen presented at Frederick Douglass high school in an effort to build partnerships and inform students preparing to enter college about the services DSSC provides.
- Celebrated Disability Awareness Month by informing faculty and staff of the services provided by DSSC, and encouraging faculty, staff and student involvement by wearing yellow in honor of that important month. Student involvement was encouraged by raffling off a school supplies basket and meal vouchers to the BCCC café.
- Interim Director Spencer-Allen attended conference on the important subject matter of how disability support services professionals can support diversity.
- Completed national search for a permanent Director, who begins February 1, 2017

#### TRIO/SSS-STAIRS Program

- Community Service at the Franciscan Center On December 21, 2016, Ascenders Club members prepared and served dinner for homeless and economically disadvantaged individuals at the Franciscan Center located in East Baltimore. Also, the club donated 25 new blankets collected from their Blankets of Love Drive in November.
- Big Hearts for Little Stars Toy Donation Drive- The Ascenders Club was successful in collecting over 70 new toys for children ages 0-17. The toys were presented to Children's Mission Inc. at the club's Holiday Social on December 19, 2016 to be distributed to children of low-income families in Baltimore City for the holidays.
- Program Presentation at Year Up Career Fair On December 9, 2016, the TRIO/SSS-STAIRS Program staff presented program information to Year Up participants during their Career Fair. The goal was to encourage Year Up graduates to continue their education at BCCC and to enroll in the STAIRS Program for continued support.

- On September 23, SGA President Devone Delly spoke on the importance of attending school every day and provided tips for students to be successful at Beechfield Elementary School for their Middle School Attendance Assemblies.

Various clubs and organizations made posters and displays that were placed in the Student Affairs Atrium for all to see.
