



## 2022 Student Right to Know Disclosure

**This report provides an overview of full-time, first-time students who entered Baltimore City Community College (BCCC) in fall 2018 and their outcomes for completion, transfer, and ongoing enrollment.**

### I. 150% Retention, Graduation, and Transfer-Out Rates

During the fall 2018 semester, 610 first-time, full-time (12 credits or more) students entered BCCC seeking a certificate or degree from the College by August 31, 2021 (for Associate Degrees) or December 31, 2019 (for Certificates). Their outcomes were as follows.

- \* 61 (10.0%) completed their BCCC degree or certificate program by the targeted time.
- \* 22 (3.6%) last attended a four-year institution of higher education without graduating from BCCC.
- \* 72 (11.8%) were still enrolled at BCCC.
- \* 85 (13.9%) last attended a two-year institution of higher education without graduation from BCCC

### II. 100% Retention, Graduation, and Transfer-Out Rates

During the fall semester of 2019, 320 students entered BCCC as full-time students for the first-time and were seeking a degree or certificate. They did not attend another postsecondary institution prior to attending BCCC. Their outcomes were as follows.

- \* 23 (3.9%) completed their BCCC programs within 100% of normal time (Two years for Associate degrees and one year for certificates).
- \* 31 (5.3%) last attended a four-year institution of higher education without graduating from BCCC.
- \* 99 (17.0%) were still enrolled at BCCC.
- \* 50 (8.6%) last attended a two-year institution of higher education without graduating from BCCC.

### III. Employment Rates

Through data sharing arrangements with the Maryland State Department of Education; Maryland Higher Education Commission; Department of Labor; and Maryland Longitudinal Data System Center, BCCC graduates' employment data are collected and reported annually for many occupational programs or program clusters via the Perkins Program Quality Index (PQI). Records for graduates of the selected programs are compared with payroll records to determine how many are employed in any field, whether full-time or part-time.
